


# How to Register a Company in BVI

# Introduction



The benefit of **zero-rate corporate income tax** and no capital gains tax. The **British Virgin Islands (BVI)** is one of the oldest and most respected offshore financial centres in the world.

# BVI for Company Formation



## 01 Why Choose BVI for Company Formation.

- BVI companies are **exempt** from **corporate tax, income tax, capital gains tax, and inheritance tax.**
- BVI offers various company structures to suit **different business needs.**
- Financial statements do not require **mandatory audits**, reducing administrative burdens.
- Provides a familiar **legal framework** for businesses.
- BVI protects the confidentiality of **company information and shareholder details.**
- Ensures **greater privacy** for company owners.

# 02 Step-by-Step Registration Process.

Step	Action
1	<b>Order:</b> Submit our online <u>Order Form</u> or <u>download</u> and complete the form and send it to us by email or courier.
2	<b>Review &amp; Invoice:</b> Your order is reviewed, the company name availability is checked, and a proforma invoice is issued.
3	<b>Due Diligence:</b> Provide <u>KYC documents</u> for Director(s), Shareholder(s), and Beneficial Owner(s) (passport, proof of address, and other required <u>documents</u> ).
4	<b>Payment:</b> Payment is required before incorporation (wire transfer or card payment).
5	<b>Registration:</b> Documents are prepared and filed with the BVI Registrar. Incorporation takes 1–2 business days.
6	<b>Documents:</b> You receive the Certificate of Incorporation, Memorandum & Articles, Registers, Share Certificates, and Resolutions.
7	<b>Certification (if needed):</b> Notary and Apostille certification can be arranged (2–4 business days).
8	<b>Delivery:</b> Documents are sent by courier worldwide (1–5 business days).
9	<b>Corporate bank account opening:</b> (2 weeks and more, depending on the chosen bank).


## 03 Required Documents.



**01. Valid passport copy:** Original presented in person or, certified true copy.



**02. Proof of Residential Address:** Utility bill or bank statement, issued within the last 3 months, original or certified true copy.



**03. Identity Verification Link:** Optional Alternative for **01**. Can replace a certified true copy, passport document, through our secure digital verification platform.



**04. Bank or professional reference letter:** Original and dated no later than 3 months old.



**05. CV (Curriculum Vitae):** Summary of education, experience, and skills.



**06. Proof of source of funds/wealth:** We provide guidance based on each individual case, but generally request bank statements, proof of company ownership, and similar supporting documents.

## 05 Post-Registration Obligations.

- Government and Registered Agent fees must be paid annually to keep the company in good standing.
- The company must always maintain a licensed Registered Agent and Registered Address in the BVI.
- Proper accounting records must be maintained and kept available upon request (no public filing required).
- All BVI entities are required to prepare, report and file an economic substance declaration about their business annually.
- Updated due diligence documents may be requested periodically by the Registered Agent.



## 06 Frequently Asked Questions.

Do I have to visit the offshore jurisdiction to incorporate the company?

No. All pre-incorporation and post-incorporation paperwork can be prepared without personal presence of the beneficial owner.

What's the difference between a shareholder and the beneficial owner?

A shareholder is the registered holder of company shares, while the beneficial owner is the real person entitled to the shares' profits and decision-making rights (which may or may not be the same person, especially where a nominee shareholder is involved).

Is a BVI IBC required to open a bank account in BVI?

No — a BVI company can open bank accounts anywhere; it doesn't have to be in the BVI.

Why would I need my offshore company documents Apostilled?

To make the documents legally usable in other countries (e.g., for banks, property registration).
